The afternoon of June 14, 1971, gentlemen Jorge Molina Moreno, Guillermo Moreno Uribe, Carlos Gutiérrez Brazo, Luis Carlos Estrada Gómez, Ricardo Ángel Villa, Germán Saldarriaga del Valle, Foción Soto Echavarría, Luis Eduardo Cadavid Hoyos and Jaime Velásquez Rango met in Medellin to comply with Minute 1,577 of the Board of Directors of Compañía Suramericana de Seguros to create an entity that would help improve the social, educational, civic, cultural conditions and overall welfare of the people. This led to the birth of Fundación Suramericana, today Fundación SURA.

The company earmarked **COP 263,620**

to create Fundación SURA in 1971.





The transfer process of Félix and Susana began in 2015. It began by validating the educational material used per regional contexts and the engagement of the program to national education policies in each country.

In 2016, the technical team in charge of the implementation will be prepared, the schools where Félix and Susana will be implemented will be chosen, and the basic training of teachers will be conducted. Implementaion is estimated to take place in 2017.

NOTES TO FINANCIAL **STATEMENTS**

AT DECEMBER 31, 2015 AND 2014 (Expressed in thousands of pesos)

REPORTING ENTITY

Fundación Suramericana was established through public deed Nr. 281 of August 2, 1971 of the Governor's Office of Antioquia, and registered at the Medellin Chamber of Commerce on March 4, 1997, in book 1, under Nr. 1048; with an indefinite legal term.

The Foundation's purpose is to participate in projects that contribute to social development, including, among others, the promotion and protection of human rights, welfare, quality of life, institutions and competitiveness, either on its own or in collaboration with other entities that share its purpose, in Colombia or overseas.

In pursuance of its objective, the Foundation may acquire and alienate for any reason, property, limit or encumber, give or receive mutual money, acquire and dispose of any title, social interests or shares in companies of any kind, and generally perform functions and perform the acts necessary or conductive to the attainment of its objective, according to the law.

At December 31, 2015, the Foundation had 7 employees and carried out its activities through a main office.

SUMMARY OF SIGNIFICANT ACCOUNTING POLICES

- (a) Basis for Preparation and Presentation
- (b) Materiality or Relative Importance

NOTE 2

The financial statements are prepared in accordance with the accounting principles generally accepted in Colombia. Pursuant to Decree 1878 of 2008, the basic financial statements of non-commercial entities are solely bound to present the balance sheet and the income statement.

Economic events are acknowledged and presented based on their relative importance. The materiality to prepare the financial statements was determined regarding current assets and liabilities to total assets and liabilities, working capital, equity, or the results of the period, whichever the case. As a general rule, the approach followed was 5% of the total value of assets and operating income.

(c) Use of Estimates

Preparing the financial statements, in accordance with the generally accepted accounting principles of Colombia, require the Foundation's management to record estimates and provisions that affect the values of assets and liabilities reported, and to disclose contingent assets and liabilities at the date of the financial statements. Real results may differ from said estimates.

(d) Investments

Investments are recorded at their cost, which does not exceed market value.

(e) Appreciations and Deappreciations

Corresponds to the appreciation of permanent investments of corporations not controlled. This corresponds to the excess of its intrinsic value over its cost in books, and is recorded in the item of appreciations and credited to surplus for appreciations. If the intrinsic value is lower than the cost in books, the difference initially affects the appreciation and its surplus up to its amount, if any; if higher, it represents a depreciation, which affects the items above mentioned with a lower value, notwithstanding if their net balance has an opposite nature.

(f) Equipment

Equipment is recorded at the acquisition cost. Depreciation is calculated by the straight line method based on the estimated life of each asset. The estimated life of computer equipment is 5 years.

(g) Taxes, Liens and Encumbrances - Income Tax

The income tax expense is determined based on the fiscal income at a 20% rate since the Foundation is a taxpayer under the Special Tax Regime.

(h) Revenues and Expenses Recognized

Revenues and expenses are recognized when the right to them arises; expenses are acknowledged by the causation system. Donations are recorded on the income statement.

NOTE 3 CONVERGENCE TO ACCOUNTING AND FINANCIAL INFORMATION STANDARDS ACCEPTED IN COLOMBIA

In accordance with Sole Regulatory Decree 2420 of 2015, amended by Decree 2496 of 2015, which rules Law 1314 of 2009 regarding the technical framework for those that prepare financial information. Fundación Suramericana, which is part of Group 2, that is, in the transition period that began January 1, 2015, and the issuance of the first financial statements based on the International Financial Reporting Standards - IFRS for Small and Medium-size businesses issued in 2009, shall take place in 2016.
