- To identify hazards, to evaluate and value risks and to establish the respective controls;
- 3. To consult, inform and educate its workers on aspects regarding security and health at work, so that they understand the risks involved in their work and the relevance of the prevention and control measures adopted.
- 4. To guarantee to the workers their right to participate before the Joint Committee of Safety and Health at Work or the body acting as such.
- 5. To implement accident prevention and labor diseases activities.
- 6. To comply with the applicable national standardization in effect on the matter of labor risks, and to look for the implementation of the best international practices.

On the other hand, the workers of Grupo SURA shall:

- 1. Look for the comprehensive care of their health;
- 2. Provide clear, truthful and complete information on their health condition:
- 3. Follow the norms, regulations and instructions of the SG-SST;
- 4. Timely inform about hazards and latent risks in their work sites;
- 5. Participate in the Safety and Health at Work activities defined in the SG-SST training plan;
- 6. To participate and contribute to the fulfillment of the SG-SST objectives.

In order to comply with as set forth herein, Grupo SURA will implement the Ssfety and Health at Work System, under the terms set forth in Decree 1072 of 2015 and any other norm that may modify or add to it.

#### Governance

The Vice Presidency of Corporate Affairs, altogether with the Internal and Shared Services Management shall review, at least once a year, the contents of this policy, and will be the one responsible for its approval and administration.
